In the financial years 2011-13 (2011-12 & 2012-13), his gross income from salary and arrears is Rs.12,04,990/- and total deductions/Savings/investments against CPF, GIS, Income Tax, Repayment of car loan and Insurance is Rs.3,46,485/-. The balance of Rs.20,462/- has decreased from his saving bank A/c's against the balance of the previous year. In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2009-11 online against case id-P00006282021 (old case id-P00006282021) and same has been processed before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Siddharth Nagar for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2011-13 (2011-12 & 2012-13) in its next financial year i.e., 2013-14 upto March 2014. He has submitted movable and immovable property statements of the financial years 2011-13 (2011-12 & 2012-13) vide online dated 10.12.2021. As such, there is delay in submitting the same. In this regard, officer verbatim: "I tender my unconditional apology for the delay".
