May kindly see the property statement online received from Sri Mahesha Nand Jha, Additional District & Sessions Judge, Aligarh, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below :

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross income is Rs.43,71,845/- (Income from salary is Rs.40,29,502/- and Income from Interest is Rs.3,42,343/-) and total deductions/repayment/savings/ investment against NPS, GIS, Income Tax, PPF, LIC, PLI and the balance of his savings bank account(s) is also enhanced by Rs.17,17,270/- in this financial year from previous year's balance, total of which is Rs.34,44,572/-. Thus, a sum of Rs.9,27,273/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements online upto the financial year 2016-18 which has already been seen by Hon'ble Mr. Justice Ashwani Kumar Mishra, the then Administrative Judge, Aligarh on old case ID no.-646.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 20.07.2021. As such, there is delay in submitting the same from the part of the officer, for which he has not given any reason.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Mahesha Nand Jha, Additional District & Sessions Judge, Aligarh be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh for His Lordship's kind perusal and orders?
