In the financial years 2013-15 (2013-14 & 2014-15), his gross income from salary is Rs.16,22,076/- and total deductions/Savings/investments against CPF, GIS, Income Tax, Repayment of car loan, PPF and Insurance is Rs.3,75,268/-. The balance of Rs.4,708/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.12,46,808/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2013-15 (2013-14 & 2014-15)..

It is pertinent mention here that's Officer's father (U.P. Government Servant) annual income was Rs.2,00,000/- for the financial years 2013-14 & 2014-15.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2011-13 (2011-12 & 2012-13) online against case id-P00006292021 (old case id-2686) and same has been processed before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Siddharth Nagar for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements of the financial years 2013-15 (2013-14 & 2014-15) vide online dated 10.12.2021. As such, there is delay in submitting the same. In this regard, officer verbatim: "I tender my unconditional apology for the delay".
