In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2017-2019 (2017-18 & 2018-19), Total income is Rs.31,59,865/- (Gross income from salary is Rs.24,29,369/- , Bank interest is Rs.6,81,272/- and Income from nominee pension of deceased brother is Rs.49,224/-) and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, LIC, STDR total of which is Rs.12,41,542/-. Thus, a sum of Rs.19,18,323/- was available with her to meet out the household expenditure of her family consisting of three members in both of the financial years and the balance of her savings bank account(s) is decreased by Rs.2,06,513/-this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted her property statements of the 2015-2017 offline and same has been approved by the Hon'ble Mr. Justice S.D Singh, the then, Administrative Judge, Hapur Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial years 2017-2019 (2017-18 & 2018-19) vide online dated 29.07.2021. As such, there is delay in submitting the same in this regard officer has not given any reason.
