<u>Registrar(J)(Budget)</u>

May kindly see the property statement online received from Sri Harish Kumar-II, Chief Judicial Magistrate, Lalitpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2011-12 & 2012-13 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2011-12 & 2012-13 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2011-12 & 2012-13, Total Gross salary is Rs.12,36,010/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, Insurance policies and NSC are Rs.3,38,906/-. Thus, a sum of Rs.8,97,104/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.36,309/- this financial year from previous year's balance.

It is pertinent to mention here that his wife's income from Home Tuition was Rs.1,20,000/- per annum.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service which had already been seen offline by Hon'ble Mr. Justice Abhinava Upadhya, the then Administrative Judge, Sitapur, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2011-12 & 2012-13 in its next financial year i.e., 2013-14 upto March 2014. He has submitted movable and immovable property statements of the financial years 2011-12 & 2012-13 firstly vide online dated 01.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "earlier Property Statement for the financial year 2012-13 was submitted on 10.04.13 by offline mode, which was not in prescribed proforma. Intimation Letter issued by Hon'ble Court got misplaced during transfer, therefore could not submit reply within time, for which he apologise, mentioned in remark column of movable proforma.
