May kindly see the property statement online received from Sushri Akanksha Garg, Additional Civil Judge(Senior Division)/A.C.J.M, Muzaffar Nagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2019-2021 (2019-20 & 2020-21), Total income is Rs.42,85,383/- (Gross income from salary is Rs.33,89,327/- , Bank interest is Rs.8,46,832/- and Income from nominee pension of deceased brother is Rs.49,224/-) and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, LIC, STDR total of which is Rs.31,28,428/-. Thus, a sum of Rs.11,56,955/- was available with her to meet out the household expenditure of her family consisting of three members in both of the financial years and the balance of her savings bank account(s) is decreased by Rs.2,52,083/- this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted her property statements of the 2017-2019 online and same has been moved before the Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Muzaffar Nagar Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial years 2019-2021 (2019-20 & 2020-21) vide online dated 29.07.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-2021 (2019-20 & 2020-21) of Sushri Akanksha Garg, Additional Civil Judge(Senior Division)/A.C.J.M, Muzaffar Nagar be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Muzaffar Nagar for Her Lordship's kind perusal and orders?
