May kindly see the property statement submitted online received from Smt. Arti Fauzdar, Additional Principal Judge, Family Court, Ambedkar Nagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2014-15 & 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-15 & 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2014-15 & 2015-16, Total income is Rs.24,00,854/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, loan and amount paid against Car purchase are Rs.11,07,362/-. Thus, a sum of Rs.12,93,492/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.1,07,370/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is in Delhi Higher Judicial Service having annual Income of Rs.31,80,000/- approx.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining into judicial service and of the financial years 2006-07 to 2011-12 which had submitted before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Muzaffarnagar for kind perusal & orders, in the misc. file of the officer. And statement of the financial years 2012-13 & 2013-14, a detailed office note has been submitted on e-service Id no.2742

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2014-15 & 2015-16 in its next financial year i.e., 2016-17 upto March 2017. She has submitted movable and immovable property statements of the financial years 2014-15 & 2015-16 vide online dated 10.08.2021. As such, there is delay in submitting the same from the part of the officer for which she has humbly submitted that she could not submitted the statement on time because of some personal problems including her major surgery, mentioned in remark column of the movable proforma.

May, therefore, if approved, property statements of the financial years 2014-15 & 2015-16 of Smt. Arti Fauzdar, Additional Principal Judge, Family Court, Ambedkar Nagar be laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Ambedkar Nagar Judgeship for His Lordship's kind perusal and orders?
