May kindly see the property statement submitted online received from Smt. Arti Fauzdar, Additional District & Sessions Judge, Muzaffarnagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2012-13 & 2013-14 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2012-13 & 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2012-13 & 2013-14, Total income is Rs.21,08,953/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, NSC, Income Tax and loan are Rs.8,24,431/-. Thus, a sum of Rs.12,84,522/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.11,49,050/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is in Delhi Higher Judicial Service having annual Income of Rs.30,58,000/- approx.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining into judicial service and of the financial years 2006-07 to 2011-12 which had submitted before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Muzaffarnagar for kind perusal & orders, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2012-13 & 2013-14 in its next financial year i.e., 2014-15 upto March 2015. She has submitted movable and immovable property statements of the financial years 2012-13 & 2013-14 vide online dated 30.07.2021. As such, there is delay in submitting the same from the part of the officer for which she has humbly submitted that she could not submitted the statement on time because of some personal problems (Mother's long cancer treatment), mentioned in remark column no. 9 of the movable proforma.

May, therefore, if approved, property statements of the financial years 2012-13 & 2013-14 of Smt. Arti Fauzdar, Additional District & Sessions Judge, Muzaffarnagar be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Muzaffarnagar Judgeship for Her Lordship's kind perusal and orders?
