May kindly see the property statement online received from Sri Radhey Shyam Yadava, District & Sessions Judge, Barabanki regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2018-19 & 2019-20, Gross income from salary is Rs. 54,92,366/- and total deductions/repayment/ savings/ investment against CPF, GIS, Income Tax, LIC policies, loans and the balance of his savings bank account(s) is enhanced for Rs.2,35,596/- this financial year from previous year's balance, total of which is Rs.28,55,177/-. Thus, a sum of Rs.26,37,189/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-19 & 2019-20.

In this connection it is submitted that officer has already submitted his property statement upto the financial year upto the financial year 2015-16 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Ram Surat Ram (Maurya), the then Administrative Judge, Jaunpur in the mIsC. file of the officer and property statements of the financial years 2016-17 & 2017-18, a detailed office note has been submitted before Hon'ble Mr. Justice Chandra Dhari Singh, Administrative Judge, Barabanki in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 29.07.2021. As such, there is delay in submitting the same, for which officer has not given any reason of delay.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Radhey Shyam Yadava, District & Sessions Judge, Barabanki be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Barabanki for His Lordship's kind perusal and orders?
