May kindly see the property statement online received from Sri Mahendra Kumar Rawat, Chief Judicial Magistrate, Jalaun at Orai regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-20 & 2020-21 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2019-20 & 2020-21, Total Gross income is Rs.39,58,284/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Insurance policies, Home loan, PLI and PPF a/cs are Rs.23,08,108/-. Thus, a sum of Rs.16,50,176/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.30,174/- this financial year from previous year's balance.

It is pertinent to mention here that his wife earns Rs.21,000/- per month from service & Rs.35,000/- per month from house rent.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2014-15 which had already been seen by Hon'ble Mr. Justice Mohammad Tahir, the then Administrative Judge, Ghazipur in the misc. file of the officer and for the property statements of the financial years 2015-16, 2016-17, 2017-18 & 2018-19, a detailed office note has already been laid before Hon'ble Dr. Justice Yogendra Kumar Srivastava, Administrative Judge, Jalaun at Orai for kind perusal & order, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-20 & 2020-21 firstly vide online dated 02.08.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial years 2019-20 & 2020-21 of Sri Mahendra Kumar Rawat, Chief Judicial Magistrate, Jalaun at Orai be laid before Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Jalaun at Orai Judgeship for His Lordship's kind perusal and orders?
