May kindly see the property statement submitted online received from Sri Mridul Dubey, Additional District & Sessions Judge, Hapur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2010-12 (2010-11 & 2011-12) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2010-12 (2010-11 & 2011-12) of the officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below:

1. In the financial year 2010-12 (2010-11 & 2011-12), his Total income from salary including arrears & allowances, is Rs.20,81,034/- and total deductions/savings/investments against GIS, PPF, Income tax, Insurances, mutual funds and the balance of his savings bank account(s) is also enhanced for Rs.1,41,937/- this financial years from previous year's balance, total of which is Rs.14,19,423. Thus a sum of Rs.6,61,611/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2008-10 which is processed before Hon'ble Mr. Justice Ashutosh Srivastava, Administrative Judge, Hapur on old case ID no-2752.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2010-12 (2010-11 & 2011-12) in its next financial year i.e., 2012-13 upto March 2013. He has submitted movable and immovable property statements for the financial years 2010-12 (2010-11 & 2011-12) vide online dated 06.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has stated that firstly he was unable to fetch the relevant information in time and secondly he has faced some personal problems, due to which, officer could not send the property statement in time. He has also appologized for delay.

May, therefore, if approved, property statements for the financial years 2010-12 (2010-11 & 2011-12) of Sri Mridul Dubey, Additional District & Sessions Judge, Hapur, be laid before Hon'ble Mr. Justice Ashutosh Srivastava, Administrative Judge, Hapur Judgeship, for His Lordship's kind perusal and order?
