May kindly see the property statement received online from Smt. Shivani Singh-I, Addl. Principal Judge, Family Court, Bareilly regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2017-2019 (2017-18 & 2018-19), the Gross income is Rs.25,94,239/- and total deductions/ repayment/ savings/ investment against GIS, CPF, Income Tax, PPF, and Insurances are Rs.8,80,941/-. Thus, a sum of Rs.17,13,298/- was therefore available with her to meet out the household expenditure of her family consisting four members of the financial year 2017-2019 (2017-18 & 2018-19) and the balance of her savings bank account is also decreased by Rs.2,93,743/- in this financial year from previous year's balance.

It is pertinent to mention here that her husband have annual income of Rs.10,80,000/- as Judicial Officer in Delhi Judicial Service.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements for the financial year 2015-16 & 2016-17 offline and the same has been seen by Hon'ble Mrs. Justice Rekha Dikshit, the then Administrative Judge, Amroha Judgeship in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has firstly submitted movable and immovable property statements of the financial year 2017-2019 (2017-18 & 2018-19) vide online dated 13.08.2021. As such, there is delay in submitting the same from the part of the officer for which she has stated in her online reply dated. 08.11.2022, that "due to annual transfer and work burden".

May, therefore, if approved, property statements for the financial year 2017-2019 (2017-18 & 2018-19) of Smt. Shivani Singh-I, Addl. Principal Judge, Family Court, Bareilly, be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
