May kindly see the property statement online received from Sri Mohd. Rizwan Ahmad, Addl. District & Sessions Judge, Kushi Nagar at Padrauna regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Total gross income from salary with allowances & arrears is Rs.46,70,651/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Mutual Fund, Income Tax, SBI Smart Life Policy and the balance of his savings bank account(s) is enhanced by Rs.6,29,997/- this financial year from previous year's balance, Total of which is Rs.22,09,501/-. Thus, a sum of Rs.24,61,150/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the F.Y. 2016-18 Online against Case Id- P00007232021 (old case id-2786) and same has been moved before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Kushinagar at Padrauna Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 09.12.2021.

As such, there is delay in submitting the same. In this regard officer has stated that he inadvertently somehow missed to submit the said statements in due course because of pressing official and personal obligations, for which he sincerely regret. It is however submitted that he will take utmost care in submitting all future property statements in due course. he sincerely apologize for the delay in submitting the property statements.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Mohd. Rizwan Ahmad, Addl. District & Sessions Judge, Kushi Nagar at Padrauna, be laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Kushinagar at Padrauna Judgeship for His Lordship's kind perusal and orders?
