May kindly see the property statement online received from Smt. Kalpana Pandey, Additional District & Sessions Judge, Saharanpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Gross income from salary is Rs.20,70,442/- and total deductions/savings/ investment against NPS, GIS, Income Tax, Repayment of Home loan & Car loan and Insurances is Rs.20,88,102/-. Thus a sum of Rs.10,34,064/-(From savings) was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2019-21 (2019-20 & 2020-21) and the balance of her savings account is also decreased for Rs.10,51,724,- this financial year from previous year balance.

It is pertinent mention here that Officer husband (Retail sale of other products, tour and travel work) having annual income Rs.5,04,000/-(approximately).

In this connection, it is submitted that the Officer has already submitted his property statement for at the time of Joining into U.P. Judicial Service online against case id- P00007382021 (Old case id-2801) and same has been processed before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Saharanpur for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial year 2019-21 (2019-20 & 2020-21) vide online dated 21.09.2021. As such, there is no delay in submission of property statement.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Smt. Kalpana Pandey, Additional District & Sessions Judge, Saharanpur be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Saharanpur for His Lordship's kind perusal and orders?
