May kindly see the property statement submitted online received from Smt. Ragini, presently posted as Additional District & Sessions Judge, Allahabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2019-21 (2019-20 & 2020-21), her Total income from salary is Rs. 34,52,577/- total deductions/savings/investments against GIS, NPS, Income Tax, PPF and FDR is Rs. 21,93,136/- (including enhancement of Rs. 4,81,067/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 12,59,441/- was therefore available with her to meet out the household expenditure of her family consisting of four members in both the financial years.

It is pertinent to mention here that her husband is an Advocate, High Court, Allahabad earned Rs. 11,00,000/- and 12,00,000/- annually for the financial years 2019-20 & 2020-21 respectively.

In this connection, it is submitted that the officer has already submitted his property statements online at the time of joining which is also processed online and laid before Hon'ble Mr. Justice Rakesh Srivastava, Administrative Judge, Allahabad Judgeship for kind perusal and order on e-service Id no. 2716.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) firstly vide her application dated 03.09.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Smt. Ragini, presently posted as Additional District & Sessions Judge, Allahabad, be laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Allahabad for his Lordship's kind perusal and orders ?
