(1) In the financial years 2018-19 & 2019-20, Total income is Rs.46,72,472/- (Gross Income from salary is Rs.36,67,084/-, matured amount of NSC of Rs.1,46,221/-, matured amount of LIC of Rs.2,26,964/-, Bank interests of Rs.2,72,203/- and Flat rent of Rs.3,60,000/-) and total deductions/repayment/ savings/ investment against GPF, GIS, Income Tax, Car loan, Insurance policies, PPF and the balance of his savings bank account(s) is enhanced for Rs.6,84,956/- this financial year from previous year's balance, total of which is Rs.18,72,099/-. Thus, a sum of Rs.28,00,373/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-19 & 2019-20.

In this connection, it is submitted that officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice B.Amit Sthalekar, the then Administrative Judge, Aligarh in the mIsc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. As such, there is delay in submitting the same, for which officer has stated that "he, inadvertently, could not submit the aforesaid statements earlier and requested to forgive the delay in submission of the statement." mentioned in his attachment dated 05.09.2021.
