May kindly see the property statement online received from Smt. Sneha Negi, Additional Principal Judge, Family Court, Gautambuddha Nagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2016-18 (2016-17 & 2017-18), Total income is Rs.32,40,900/- (Gross income from salary is Rs.28,01,950/- and from other sources is Rs.4,38,950/- and total deductions/ repayment/ savings/ investment against GIS, GPF, SBI Mutual Fund, LIC Policy and the balance of her savings bank account(s) is enhanced by Rs.60,316/- this financial year from previous year's balance, total of which is Rs.24,48,603/-. Thus, a sum of Rs.7,92,297/- was available with her to meet out the household expenditure of her family consisting of two members in both of the financial years.

It is pertinent to mention here that her husband is working as a teacher having income Rs.3,25,000/- in both the financial years.

In this connection, it is submitted that the Officer has already submitted her property statements of the 2014-16 offline and same has been approved by the Hon'ble Ms. Justice Bharati Sapru, the then, Administrative Judge, Kanpur Nagar Judgeship in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online dated 08.10.2021. As such, there is delay in submitting the same. In this regard officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Smt. Sneha Negi, Additional Principal Judge, Family Court, Gautambuddha Nagar be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Gautambuddha Nagar for His Lordship's kind perusal and orders?
