May kindly see the property statement received online from Smt. In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.12,53,453/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Insurances, Car Loan repayments including amount paid other than loan and Income Tax are Rs.5,66,963/- and the balance of her savings bank account is also increased by Rs.3,000/- in this financial year from previous year's balance, total of which is Rs.5,69,963/-. Thus, a sum of Rs.6,83,490/- was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial year 2019-2021 (2019-20 & 2020-21).

It is pertinent to mention here that her husband have monthly income of Rs.35,000/- from Self Employment Business (as mentioned by the officer).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held at the time of joining into U.P. Judicial Service online against Case Id: P00007692021 (Old Case Id: 2836) and the same has been seen by Hon'ble Mr. Justice Om Prakash-VII, the then Administrative Judge, Bulandshahr Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 01.02.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Smt. Priyanka Sharma, Civil Judge (Junior Div.), Mau, be laid before Hon'ble Mr. Justice Chandra Kumar Rai, Administrative Judge, Mau Judgeship for His Lordship's kind perusal and orders?
