May kindly see the property statement online received from Smt. Vandana-I, Civil Judge (Junior Div.), Vidhuna-Auraiya regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary & other sources is Rs.21,87,243/- (income from salary Rs.20,93,881/- and income from Interests of S.B., ITR, deposit & house property Rs.93,362/-)and total deductions/repayment/ savings/ investment against GIS, NPS, INCOME TAX, LIC, PLI, tuition fees and the balance of her savings bank account(s) is enhanced by Rs.6,54,796/- this financial year from previous year's balance, total of which is Rs.10,92,351/-. Thus, a sum of Rs.10,94,892/- was available with her to meet out the household expenditure of her family consisting of three members in both of the financial years.

It is pertinent to mention here that Mr. Deepak Kumar (Husband) Government Service as Jr. Assistant in ARSD College (University of Delhi) Since December 2008. His Annual income from salary is Rs. 4,80,000/- approx.

In this connection, it is submitted that the Officer has already submitted her property statements of at the time of joining online and same has been approved by the Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Muzaffarnagar in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 16.09.2021. As, there is delay in submitting the same from the part of the officer, for which officer has stated that Due to spread of pandemic Covid-19, he was also infected with covid-19, so he could not submit the same in time. He most humbly apologizes for the delay.
