May kindly see the property statement submitted online dated 24.09.2021 received from Sri Mohammad Azad, Additional District & Sessions Judge (POCSO), Jalaun at Orai, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-20 (2018-19 & 2019-20), gross salary is Rs.36,39,837/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, LIC and the balance of his savings bank account(s) is also enhanced for Rs.28,198/- this financial year from previous year's balance, total of which is Rs.16,13,551/-. Thus, a sum of Rs.20,26,286/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

It is pertinent to mention here that his wife's (Farmina Khatoon) annual income is Rs. 5 lacs approx (as an advocate).

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2016-18 which had already been seen offline by Hon'ble Mr. Justice Surya Prakash Kesarwani, the then Administrative Judge, Ballia in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 24.09.2021. As such, there is delay in submitting the same, for which, officer has not given any reason.

May, therefore, if approved, property statements of the financial years 2018-20 (2018-19 & 2019-20) of Sri Mohammad Azad, Additional District & Sessions Judge (POCSO), Jalaun at Orai be laid before Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Jalaun at Orai Judgeship for His Lordship's kind perusal and orders?
