May kindly see the property statement online received from Sri Ram Pratap Singh, Spl. J. (SC/ST, Pev.of Atroci Act), Hathras regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2014-16 (2014-15 & 2015-16) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2014-16 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2014-16 (2014-15 & 2015-16)**, Gross income from salary is Rs.28,21,470/- and total deductions/savings/ investment against GPF, GIS, PPF, Income Tax, Insurances, Car loan EMI & down-payment and the balance of his savings bank account(s) is also enhanced by Rs.2,590/- in this financial year from previous year's balance, total of which is Rs.11,55,293/-. Thus, a sum of Rs.16,66,177/- was therefore available with him to meet out the household expenditure of his family consisting four members in the both of the financial year.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2012-14 (2012-13 & 2013-14) online against case id- P00007832021( old case id-2852) and same has been processed before Hon'ble Mr. Justice Anish Kumar Gupta, Administrative Judge, Hathras Judgship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2014-16 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements of the financial year 2014-16 (2014-15 & 2015-16) vide online dated 17.09.2021. As such, there is delay in submitting the same. In this regard, officer has not given any reason.
