May kindly see the online property statements received from Smt. Neelima Singh, Addl. District & Sessions Judge, Prayagraj regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2009-10 & 2010-11 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2009-10 & 2010-11 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2009-10 & 2010-11, Total Gross income from salary is Rs.6,96,948/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income tax, PPF, Car loan and the balance of her savings bank account(s) is enhanced for Rs.34,919/- this financial year from previous year's balance, total of which is Rs.2,34,233/-. Thus, a sum of Rs.4,62,715/- was therefore available with her to meet out the household expenditure of her family consisting two members in both the financial years.

It is pertinent to mention here that her husband's annual income was of Rs.1,50,000/- from Advocacy.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining into judicial service which had already been seen by Hon'ble Mr. Justice Abhinava Upadyay, the then Administrative Judge, Jaunpur placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2009-10 & 2010-11 in its next financial year i.e., 2011-12 upto March 2012. She has submitted movable and immovable property statements of the financial years 2009-10 & 2010-11 vide online dated 11.12.2021. As such, there is delay in submitting the same from the part of the officer for which she has stated that "Due to inadvertence, the property statement could not be sent in time. She extents her apology for not sending in time. She ensures that she will regularly send the property statement in time" mentioned in remark column of movable proforma.

May, therefore, if approved, property statements of the financial years 2009-10 & 2010-11 (2009-11) of Smt. Neelima Singh, Addl. District & Sessions Judge, Prayagraj be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Prayagraj Judgeship for His Lordship's kind perusal and orders?
