May kindly see the property statement submitted online received from Sri Iftekhar Ahmad, Additional District and Sessions Judge, Bareilly regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary and other sources is Rs. 48,35,668/- (Total Salary Rs. 37,93,232/-, EL encashment Rs. 124561/-, D.A. Arrears Rs. 53964/-, I.R. Rs. 4,61,031/-, Petrol Rs. 1,14,307/-, Arrear Pay Rs. 98,573/-, HRA Rs. 1,75,000/-, Spex Rs. 15,000/-) and total deductions/savings/investments against GPF, GIS, Income Tax, Insurances, PPF and Home Loan and the balance of his Saving bank A/c is enhanced for Rs. 66,069/- this financial year from previous year's balance, total of which is Rs. 24,63,307/-. Thus a sum of Rs. 23,72,361/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2017-18 and seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Kaushambi.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto 31st March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 24.09.2021 As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Iftekhar Ahmad, Additional District and Sessions Judge, Bareilly, be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Bareilly for His Lordship's kind perusal and order?
