It is pertinent to mention here that her husband is working as a teacher having income Rs.3,67,000/- in both the financial years.

In this connection, it is submitted that the Officer has already submitted her property statements of the 2016-18 online against case id-P00007672021 and same has been moved before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Gautambuddha Nagar Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 08.10.2021. As such, there is no delay in submitting the same.
