May kindly see the property statement online received from Sri Saif Ahmad, Additional Principal Judge, Family Court, Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-20 (2018-19 & 2019-20), Total income is Rs.34,82,114/- (Gross income from salary is Rs.34,72,197/-, and Bank Interest of Rs.9,717/- respectively) and total deductions/ repayment/ savings/ investment against Gis,Nps,Income tax,Ppf, Lic policy's,Life policy,Muthal fund and the balance of his savings bank account(s) is enhanced for Rs.1,35,543/- this financial year from previous year's balance, total of which is Rs.10,61,890/-. Thus, a sum of Rs.24,20,224/- was therefore available with him to meet out the household expenditure of his family consisting four members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the financial year 2016-18 and same has been moved before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar for kind perusal & order.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 09.11.2021. As such, there is delay in submitting the same. In this regards officer has stated that his mother was suffering from old age illness. After a long treatment she died on 25th November 2018. Due to his frequent transfers his documents were left at parental home. he couldn't collect the documents due to Covid. for which he is seeking unconditional apologise for the delay.

May, therefore, if approved, property statements for the financial year 2018-20 (2018-19 & 2019-20) of Sri Saif Ahmad, Additional Principal Judge, Family Court, Kanpur Nagar be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar for His Lordship's kind perusal and orders?
