

## **Registrar(J)(Budget)**

May kindly see the property statement online received from Smt. Shabistan Aquil, Spl. Judge (U.P. Dacoity.A.A.), Lalitpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2018-20 (2018-19 and 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial years 2018-20 (2018-19 and 2019-20)**, her gross income from salary and allowances are Rs.39,44,933/- and total deductions/Savings/investments against Deposits in Saving Bank Account, NPS, GIS, Income Tax, PPF and Insurances are Rs.11,00,608/-. The balance of Rs.12,784/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.28,44,325/- was therefore available with her to meet out the household expenditure of her family consisting four members in the financial years 2018-20 (2018-19 and 2019-20).

It is pertinent to mention here that officer's husband (Assistant General Manager in Air India, New Delhi) having annual income was Rs.14,88,000/- for the financial year 2018-19 and Rs.16,20,000/- for the financial year 2019-20 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2012-13 to 2017-18 offline. Which had already been seen by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Muzaffarnagar Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 and 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She had submitted movable and immovable property statements for the financial years 2018-20 (2018-19 and 2019-20) vide online dated 11.12.2021 on eServicesJo portal. As such, there is delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 and 2019-20) of Smt. Shabistan Aquil, Spl.Judge (U.P.Dacoity.A.A.) Lalitpur be laid before Hon'ble Mr. Justice Mayank Kumar Jain, Administrative Judge, Lalitpur Judgeship for His Lordship's kind perusal and orders?
