May kindly see the property statement online received from Sri Saif Ahmad, Additional Principal Judge, Family Court, Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2012-14 (2012-13 & 2013-14) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2012-14 (2012-13 & 2013-14) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2012-14 (2012-13 & 2013-14), Total income is Rs.16,55,592/- (Gross income from salary is Rs.15,60,208/-, and Bank Interest of Rs.95,384/- respectively) and total deductions/ repayment/ savings/ investment against Gis,Nps,Income tax,Car loan,Ppf, Lic policy's,Life policy and the balance of his savings bank account(s) is enhanced for Rs.48,916/- this financial year from previous year's balance, total of which is Rs.4,43,840/-. Thus, a sum of Rs.12,11,752/- was therefore available with him to meet out the household expenditure of his family consisting four members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of at the time of joining and of the financial year 2006-07,2007-08,2008-09,2009-10,2010-11 and 2011-12 be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Administrative Judge, Kanpur Nagar for kind perusal & order, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2012-14 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto March 2015. He has submitted movable and immovable property statements of the financial years 2012-14 (2012-13 & 2013-14) vide online dated 09.11.2021. As such, there is delay in submitting the same. In this regards officer has stated that his father was cancer patient. After prolonged treatment, he died on 31st July, 2013. After the death of his father, his mother became ill hence, he was busy in her treatment and day to day care. he is seeking unconditional apologise for delay.

May, therefore, if approved, property statements for the financial years 2012-14 (2012-13 & 2013-14) of Sri Saif Ahmad, Additional Principal Judge, Family Court, Kanpur Nagar be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar for His Lordship's kind perusal and orders?
