May kindly see the online application dated 26.10.2021 by which Sri Ashok Kumar Singh, Additional District and Sessions Judge, Bulandshahar, has submitted his movable and immovable property statement held at the time of entering the Uttar Pradesh, Higher Judicial Services i.e his joining time 25.03.2021.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his/her property statement held at the time of joining the Uttar Pradesh, Judicial Services/Higher Judicial Services on or just after the joining into the Uttar Pradesh, Judicial Services/Higher Judicial Services. He has submitted the aforesaid statement through his online request dated 26.10.2021. As such, there is delay in submitting the aforesaid statement from the part of the officer. In reply to the query of office dated 20.10.2021 regarding permission of purchase of car alongwith reason for delay in submission of property statement, the officer in his reply dated 26.10.2021 has mentioned that the reason for delay in submission of statement regarding purchase of new car is that he received the R/C very late due to Covid- 19 in the month of September (issue date 09.09.2021) and during that period he was participating in training programme organized by J.T.R.I., Lucknow i.e. from 06.09.2021 to 05.10.2021 and he has already submitted the information regarding purchase of new car. Therefore, it is humbly requested that delay caused in submission of statement may kindly be condoned.

It is further submitted in this regard that the officer did not mention clearly the reason for delay in submission of property statement in his reply dated 20.10.2021. Again, a query was raised by office on 27.10.2021 regarding delay in submission of property statement. In his reply dated 27.10.2021, the officer has most respectfully submitted that he joined service on 25.03.2021 and after that court was closed on account of Covid-19, after that he remained under training at J.T.R.I. (Lucknow) till 05.10.2021, he thereafter filed the property statement. In the end, the officer has mentioned that the delay caused in filing the property statement may kindly be condoned.

May, if approved, the statements of movable and immovable property held at the time of entering the Uttar Pradesh, Higher Judicial Services of Shri Ashok Kumar Singh, Additional District and Sessions Judge, Bulandshahar kindly be laid before Hon'ble Mr. Justice Om Prakash-VII, Administrative Judge, Bulandshahr Judgeship for His Lordship's kind perusal and orders?
