May kindly see the property statement received online from Sri Rameshwar, District & Sessions Judge, Mau regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2018-2020 (2018-19 & 2019-20)**, the Gross income from salary is Rs.51,39,250/- and total deductions/savings/investment against GIS, NPS, PPF, PLI, Insurances, FDR and Income Tax is Rs.23,34,786/- and the balance of his savings bank account(s) is also increased by Rs.33,191/- in this financial year from previous year's balance, total of which is Rs.23,67,977/-. Thus, a sum of Rs.27,71,273/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2018-2020 (2018-19 & 2019-20).

It is pertinent to mention here that his wife Smt. Santosh working as Teacher, have monthly income of Rs.57,000/- in both financial year.

In this connection, it is submitted that the Officer has already submitted his property statements for the financial year 2016-2018 (2016-17 & 2017-18) offline and the same have been seen by Hon'ble Mr. Justice A. R. Masoodi, the then Administrative Judge, Mainpuri Judgeship, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 12.11.2021. As such, there is delay in submitting the same from the part of officer, for which he has stated in his online reply dated 20.05.2024, that "*due to busy in treatment of myself and my ailing mother, I could not submit property statement in time. The undersigned is tendering unconditional apology for not sending the same in time.*"

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sri Rameshwar, District & Sessions Judge, Mau, be laid before Hon'ble Mr. Justice Chandra Kumar Rai, Administrative Judge, Mau Judgeship for His Lordship's kind perusal and orders?
