May kindly see the property statement online received from Sri Vipin Kumar-I, Principal Judge, Family Court, Agra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20(2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20(2018-19 & 2019-20), Total income is Rs.49,51,198/- (Gross income from salary is Rs.48,75,898/-, Received from UP Van Nigam for legal advise is Rs.26,400/-, Govt. Arbritration is Rs.22,500/- and Receipt from SGPGI for Legal Advise is Rs.26,400/-) and total deductions/ repayment/ savings/ investment against GPF, GIS, PPF, LIC, Income Tax, Car Loan EMI, Home Loan EMI, ICICI Policy and the balance of his savings bank account(s) is enhanced by Rs.2,04,563/- this financial year from previous year's balance, total of which is Rs.32,85,941/-. Thus, a sum of Rs.16,65,257/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

It is pertinent to mention here that officer has mentioned "some FDRs (source before marriage of his second wife mentioned in FY 2010-11)", in column no.3 of movable proforma.

In this connection, it is submitted that the Officer has already submitted his property statements of the F.Y. 2016-18 offline and same has been approved by the Hon'ble Mr. Justice R.R Awasthi, the then, Administrative Judge, Lucknow Judgeship in Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 20.10.2021. As such, there is delay in submitting the same. In this regard officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Vipin Kumar-I, Principal Judge, Family Court, Agra be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra for His Lordship's kind perusal and orders?
