

## **Joint Registrar (J) (Budget)**

May kindly see the online application received from Sri Neeraj Kumar Garg, Additional District and Sessions Judge, Bulandshahr regarding submission of statements of movable and immovable properties for the financial years 2019-21 (2019-20 and 2020-21) on proforma to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 and 2020-21) of the officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial years 2019-21 (2019-20 and 2020-21), his total gross income from salary is Rs. 41,05,206/- and total deductions/savings/investments against DCI, GIS, Income Tax, PPF, purchase of car and the balance of his Savings Bank Accounts is enhanced by Rs. 37,216/- this financial year from previous year's balance, total of which is Rs. 24,67,510/-. Thus, a sum of Rs. 16,37,696/- was therefore available with him to meet out the household expenditure of his family consisting of 5 members in the financial years 2019-21 (2019-20 and 2020-21).

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2014-15 which has already been seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Allahabad in the Misc. file of the officer. It is also submitted in this regard that the officer has submitted the property statements for the years 2015-17 and 2017-19 which have been processed on e-service ids no. 3004 and 3005 respectively and placed before Hon'ble Mr. Justice Om Prakash-VII, Administrative Judge, Bulandshahr Judgeship for His Lordship's kind perusal and orders.

The movable and immovable property statements for the financial years 2019-21 (2019-20 and 2020-21) have been submitted by the officer vide his online application dated 23.10.2021 which were due to be submitted upto the end of the financial year 2021-22 and there is no delay in submitting the property statements.

May, if approved, the statements of movable and immovable property for the financial years 2019-21 (2019-20 and 2020-21) of Sri Neeraj Kumar Garg, Additional District and Sessions Judge, Bulandshahr may kindly be placed before Hon'ble Mr. Justice Om Prakash-VII, Administrative Judge, Bulandshahr Judgeship for His Lordship's kind perusal and orders.
