May kindly see the property statement submitted online received from Smt. Neha Anand, Additional District and Sessions Judge, Ambedkar Nagar at Akbarpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2018-20 (2018-19 & 2019-20), her Total income from salary is Rs.39,32,320/- and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, Insurances, Shares and the balance of her savings bank account(s) is also enhanced for Rs.5,06,842/- this financial year from previous year's balance, total of which is Rs.21,49,558/- Thus a sum of Rs.17,82,762/- was therefore available with her to meet out the household expenditure of her family consisting of three members in both the financial years.

It is pertinent to mention here that the Officer's husband, Sri Ashish Varma is also Additional District and Sessions Judge (POCSO), Ambedkar Nagar at Akbarpur.

In this connection, it is submitted that the officer has already submitted her property statements online for the financial year 2016-18 (2016-17 & 2017-18) which is also processed online and laid before Hon'ble Mr. Justice Rajendra Kumar-IV, Administrative Judge, Ambedkar Nagar for his Lordship's kind perusal and order on e-service Id no. 805.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto 31st March 2021. She has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly on dated 07.11.2021. As such, there is delay in submitting the same from the part of the officer. For this the officer has stated that she could not submit the property statements on time due to Corona pandemic and her transfer in that year, for which she apologizes (letter can be seen in the attachment titled 'Letter Property Statement').

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Smt. Neha Anand, Additional District and Sessions Judge, Ambedkar Nagar at Akbarpur, be laid before Hon'ble Mr. Justice Rajendra Kumar-IV, Administrative Judge, Ambedkar Nagar for His Lordship's kind perusal and order?
