May kindly see the online property statements received from Sri Vinod Kumar-III, District & Sessions Judge, Bareilly regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), his gross income from salary and other sources is Rs.62,59,192 (Rs.54,97,198/- from salary and Maturity of PLI is Rs.7,62,000/-) and total deductions/Savings/investments against Savings in Bank account, GPF, GIS, Income Tax, GVR ,Repayment of Home loan, Insurance, FDR and PPF is Rs.53,54,806/-. The balance of Rs.2,84,951/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.9,04,386/- was therefore available with him to meet out the household expenditure of his family consisting two members in the financial years 2018-20 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2016-18 (2016-17 & 2017-18) in offline mode, which has been already seen by Hon'ble Mr. Justice Rajnish Kumar, the then Administrative Judge, Lakhimpur Kheri Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay submitting the same. In this regard, officer verbatim: " It is most respectfully submitted that the property statement of the undersigned for the financial year 2018 to 2019 & 2019 to 2020 was due on 1 April 2021. For submitting property statement of the above period there was requirement of some relevant bank statements which due to Covid-19 pandemic took some time. Due to the above reason there was delay in furnishing the property statement for which the undersigned feels regret & assures that the same will not happen in future."

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Vinod Kumar-III, District & Sessions Judge, Bareilly be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
