May kindly see the property statement submitted online received from Sri Manoj Kumar-II, Chief Judicial Megistrate, Pratapgarh, regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2015-17 (2015-16 & 2016-17), his total income from salary and other sources is Rs.19,64,899/- (Income from salary including arrears Rs.-19,16,131/- and Income from Interests Rs.48,768/-) and total deductions/savings/investments against GIS, NPS, Income Tax, Insurances, PPF and PLI is Rs.9,33,225/- (including enhancement of Rs.46,719/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 10,31,674/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2013-15 which had already been seen by Hon'ble Mr. Justice Vipin Sinha, Administrative Judge, Siddharth Nagar Judgship offline in the Misc. file of the officer with the remark that the officer concerned may be requested through District Judge, Siddharthnagar to be more punctual in the submission of his property statement and the same should be submitted timely.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto 31st March 2018. He has submitted movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) firstly vide his application dated 27.11.2021. As such, there is delay in submitting the same from the part of the officer, for which he was highly regretted and ensure that the statement will be submitted within due time in future .

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Manoj Kumar-II, Chief Judicial Megistrate, Pratapgarh, be laid before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Pratapgarh Judgship for His Lordship's kind perusal and orders?
