May kindly see the property statement submitted online received from Sri Manoj Kumar-II, Chief Judicial Megistrate, Pratapgarh, regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2017-19 (2017-18 & 2018-19), his total income from salary and other sources is Rs. 35,41,013/- (Income from salary including arrears Rs.-29,40,747/-, Income from maturity amount of NSC and LIC is Rs.5,59,450/- and Income from S.B.A/c Interests Rs.40,816/-) and total deductions/savings/investments against GIS, NPS, Income Tax, Insurances, PPF and PLI is Rs.13,22,843/- (including enhancement of Rs.1,62,792/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 22,18,170/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2015-17 which has already been processed online on old case id no. 3019 before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Pratapgarh Judgeship.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto 31st March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) firstly vide his application dated 27.11.2021. As such, there is delay in submitting the same from the part of the officer, for which he was highly regretted and in future the statement will be submitted within due time .

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Manoj Kumar-II, Chief Judicial Megistrate, Pratapgarh, be laid before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Pratapgarh Judgeship for His Lordship's kind perusal and orders?
