

## **Joint Registrar (J) (Budget)**

May kindly see the online application received from Shri Prashant Shukla, Additional Chief Judicial Magistrate, Faizabad regarding submission of statements of movable and immovable properties for the financial years 2017-19 (2017-18 and 2018-19) on proforma to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 and 2018-19) of the officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial years 2017-19 (2017-18 and 2018-19), his total gross income from salary is Rs. 19,29,535/- and total deductions/savings/investments against CPF/NPS, GIS, Income Tax, PPF and the balance of his Savings Bank Accounts is reduced by Rs. 3015/- this financial year from previous year's balance, total of which is Rs. 5,62,968/-. Thus, a sum of Rs. 13,66,567/- was therefore available with him to meet out the household expenditure of his family consisting of 3 members in the financial years 2017-19 (2017-18 and 2018-19). It is pertinent to mention here that Sri Rajendra Prasad Shukla (father of the officer) is an earning member whose annual income is approx. ten lacs including agricultural income.

In this connection, it is submitted that the officer has already submitted his property statements at the time of joining which has already been seen by Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Faizabad Judgeship processed on e-service id no. 2160. It is also submitted in this regard that the officer has submitted the property statements for the year 2015-17 which has been processed on e-service id no. 3025 and placed before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Faizabad Judgeship for His Lordship's kind perusal and orders.

The movable and immovable property statements for the financial years 2017-19 (2017-18 and 2018-19) have been submitted by the officer vide his online application dated 02.11.2021 which were due to be submitted upto the end of the financial year 2019-20 and there is delay in submitting the property statements for which the officer has tendered an unconditional apology and has given an undertaking that such delay will not occur in future.

May, if approved, the statements of movable and immovable property for the financial years 2015-17 (2015-16 and 2016-17) of Shri Prashant Shukla, Additional Chief Judicial Magistrate, Faizabad may kindly be placed before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Faizabad Judgeship for His Lordship's kind perusal and orders.
