May kindly see the property statement online received from Sri Harendra Prasad, Additional District & Sessions Judge, Mathura, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2014-16 (2014-15 & 2015-16) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-16 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2014-16 (2014-15 & 2015-16), gross income from Salary & other sources is Rs.29,15,431/- (income from salary including arrears Rs.26,63,348/- & income from interest of S.B. a/c Rs.2,52,083/-) and total deductions/repayment/ savings/ investment against GPF, GIS, PPF, Income Tax, repayment of loan and the balance of his savings bank account(s) is enhanced for Rs.8,59,998/- this financial year from previous year's balance, total of which is Rs.21,31,463/-. Thus, a sum of Rs.7,83,968/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2014-16 (2014-15 & 2015-16).

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2012-14 which has already been processed before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Mathura on old case ID no-3026.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2014-16 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements of the financial years 2014-16 (2014-15 & 2015-16) vide online dated 02.11.2021. As such, there is delay in submitting the same from the part of the officer. For which, he stated that he could not submit property statement in time due to some unavoidable circumstances and ensure that in future he will submit the same in time.

May, therefore, if approved, property statements for the financial years 2014-16 (2014-15 & 2015-16) of Sri Harendra Prasad, Additional District & Sessions Judge, Mathura be laid before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Mathura for His Lordship's kind perusal and orders?
