May kindly see the property statement online received from Dr. Vivek Kumar-II, Additional Civil Judge (Senior Division)/ ACMM, Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Total Income from salary and other sources is Rs.28,16,288/- (income from maturity amount of National Saving Certificate Rs.2,77,848/-, income from maturity amount of First Smart Save Plan Policy Rs.1,02,500/-, income from maturity amount of F.D. Rs.26,691/- and income from chief minister's relief fund Rs.2161/-) and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, F.D., repayment of car loan, Kisan Vikas Patra, Insurance Policies and the balance of his savings bank account(s) is enhanced for Rs.15,127/- this financial year from previous year's balance, total of which is Rs.20,41,413/-. Thus, a sum of Rs.7,74,875/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2016-18 online and same has been processed before the Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar Judgeship on old case Id no-3065.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 05.12.2021. As such, there is delay in submitting the same. In this regard officer has stated that due to overload of work and covid-19 pandemic, he could not send the preoperty statement on time, for which he apologises for delay submission.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Dr. Vivek Kumar-II, Additional Civil Judge (Senior Division)/ ACMM, Kanpur Nagar be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar for His Lordship's kind perusal and orders?
