May kindly see the property statement online received from Sri Ravindra Kumar-IV, Presiding Officer, Motor Accident Claims Tribunal, Hardoi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Gross income from salary is Rs.44,06,184/- and total deductions/ repayment/ savings/ investment against House Loan, LIC Policy's, PPF, GIS, Income Tax, NPS and the balance of his savings bank account(s) is enhanced by Rs.9,26,341/- this financial year from previous year's balance, total of which is Rs.26,98,817/-. Thus, a sum of Rs.17,07,367/- was available with him to meet out the household expenditure of his family consisting of Six members in both of the financial years.

It is pertinent to mention here that his Father's Agricultural Income is about Rs.8.45 Lakhs annually.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2017-19 (2017-18 & 2018-19) offline and same has been moved before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Hardoi Judgeship in Misc. file of the Officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 10.11.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Ravindra Kumar-IV, Presiding Officer, Motor Accident Claims Tribunal, Hardoi be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Hardoi for His Lordship's kind perusal and orders?
