May kindly see the online reply dated 01.07.2023 received from Sri Rakesh Patel, Addl. District & Sessions Judge, Mainpuri, in compliance of order of Hon'ble Mr. Justice Rajnish Kumar, the then Administrative Judge, Deoria, in the matter of property statements for the financial year 2018-2020 (2018-19 & 2019-20), communicated to the officer.

In this connection, it is submitted that the officer had submitted his movable & immovable property statements for the financial year 2018-2020 (2018-19 & 2019-20), which was put up before Hon'ble the Administrative Judge, Deoria through detailed office note dated 20.12.2022, on which His Lordship has been pleased to pass the following order dated 21.03.2023:

"Call reason for delay in submission of Property Statement from the Officer."

The order of the Court had been communicated to the officer concerned on 22.03.2023.

In reply/compliance of the Hon'ble Court's Order, the officer concerned has stated in his reply as attachment dated 01.07.2023, that:

“सम्मान निवेदन है कि वर्ष 2020-2021 में न केवल अपना देश बल्कि विश्व के लगभग सभी देश कोरोना महामारी से गम्भीर रूप से प्रभावित थे। कोरोना महामारी के दौरान आंकड़ों को इकट्ठा किया जाना लगभग असम्भव था। जैसे ही परिस्थितियां सामान्य हुईं मेरे द्वारा आवश्यक आंकड़ों को संकलित कर सम्पत्ति का विवरण माननीय उच्च न्यायालय को प्रेषित किया गया।

यद्यपि कि सम्पत्ति का विवरण प्रेषित किये जाने में जानबूझकर कोई त्रुटि / लापरवाही नहीं की गयी है। फिर भी सम्पत्ति का विवरण प्रेषित किये जाने में यदि कोई त्रुटि हुई है तो इसके लिए प्रार्थी द्वारा बिना शर्त क्षमा याचना किया जा रहा है।”

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 vide online dated 08.12.2021. As such there is delay in submitting the property statement of the aforesaid financial year. In this regard, officer has given reason and compliance the Hon'ble Court's order.

May therefore, if approved, movable & immovable property statement for the financial year 2018-2020 (2018-19 & 2019-20) alongwith the reply/ compliance of Hon'ble Court's order, as desired by the Court in the matter, furnished by Sri Rakesh Patel, Addl. District & Sessions Judge, Mainpuri, be laid before Hon'ble Mr. Justice Donadi Ramesh, Administrative Judge, Mainpuri Judgeship for His Lordship's kind perusal and orders.
