May kindly see the property statement online received from Smt. Anita Raj, Presiding Officer, Motor Accident Claims Tribunal, Hapur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.48,85,509/- and total deductions/savings/ investment against GPF, GIS, PPF, Income Tax, Repayment of loans and the balance of her savings bank account(s) is also enhanced by Rs.11,42,834/- in this financial year from previous year's balance, total of which is Rs.34,92,654/-. Thus, a sum of Rs.13,92,855/- was therefore available with her to meet out the household expenditure of her family consisting three members in the both of the financial year.

It is pertinent mention here that's officer's husband ( Principal Judge, Family Court, Hapur in to U.P. Judicial Service) having annual income for the financial year Rs. 24,79,890/- and Rs.26,61,973/- respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial year 2016-18(2016-17 & 2017-18), which has been seen Hon'ble Mr. Justice Ramesh Sinha, the then, Administrative Judge, Ghaziabad, Misc. file of the officer..

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 11.11.2021. As such, there is delay in submitting the same. In this regard, officer humbly informed that's due to covid and time to time lockdown that's reason , officer did not send property statement.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Smt. Anita Raj, Presiding Officer, Motor Accident Claims Tribunal, Hapur be laid before Hon'ble Mrs. Justice Saroj Yadav, Administrative Judge, Hapur for Her Lordship's kind perusal and orders?
