May kindly see the property statement submitted online received from Sri Yajuvendra Vikram Singh, Additional District & Sessions Judge (F.T.C.), Firozabad regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2015-17 (2015-16 & 2016-17), his Total income from salary is Rs. 21,38,461/- and total deductions/savings/investments against NPS, GIS, Income Tax, Insurances (LICs), repayment of Home Loan, PPF, Personal Loan, NSC, FDR and the balance of his Saving bank A/c(s) is enhanced for Rs. 18,523/- this financial year from previous year's balance, total of which is Rs. 12,83,688/-. Thus a sum of Rs. 8,54,773/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2014-15 which has already been seen offline by Hon'ble Mr. Justice Ram Surat (Ram) Maurya, the then Administrative Judge, Jaunpur Judgeship on 25.07.2016 in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto 31st March 2018. He has submitted movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) firstly vide his application dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer and the officer has stated that he couldn't submit the property statement for year 2015-17 in time because of his aged old mother which was virtually bed ridden and was residing with him and most time was spent in her daily care and despite wholehearted concerted care, she could not survive and proceeded to heavenly abode on. In future he ensures that no such delay takes place.

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Yajuvendra Vikram Singh, Additional District & Sessions Judge (F.T.C.), Firozabad, be laid before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders?
