May kindly see the property statement submitted online received from Smt. Deepika Attri, Additional Civil Judge (Jr. Div.), Meerut regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2018-20 (2018-19 & 2019-20), her total income from salary is Rs.15,90,098/- and total deductions/savings/investments against GIS, Income Tax, PPF, HRA and the balance of his Saving bank A/c(s) is also enhanced for Rs.37,292/- this financial year from previous year's balance, total of which is Rs.2,57,017/-. Thus a sum of Rs.13,33,081/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that the Officer's father's annual income is apprx. 2,50,000/- from Pension (retired army personnel).

In this connection, it is submitted that the officer has already submitted her property statements online at the time of joining, which had already been processed (old case ID-2524) before Hon'ble Mrs. Justice Manju Rani Chauhan, Administrative Judge, Hathras.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide her application dated 17.11.2021. As such, there is delay in submitting the same from the part of the officer. For which she stated that the delay occured due to covid-19 pandemic, also apologizes for the delay and ensure that the mistake will not be repeated in future.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Smt. Deepika Attri, Additional Civil Judge (Jr. Div.), Meerut be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Meerut for His Lordship's kind perusal and orders?
