May kindly see the property statement online received from Sri Vivek Kumar Singh-I, Additional Chief Judicial Magistrate (Railway), Bareilly regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial year 2017-18 & 2018-19, Total income is Rs.29,68,305/- (Gross income is Rs.23,91,812/- and income from other sources of Rs.5,76,493/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, Insurance policies, PPF and the balance of his savings bank account(s) is enhanced for Rs.6,41,547/- this financial year from previous year's balance, total of which is Rs.12,06,428/-. Thus, a sum of Rs.17,61,877/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

It is pertinent to mention here that his wife is Doctor (Pathologist) having annual income of Rs.7,68,000/- and Rs.8,90,304/- in the financial years 2017-18 & 2018-19 respectively.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service and for the financial years 2015-16 & 2016-17 be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Bareilly for kind perusal & orders, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "he could not be submitted the aforesaid statements within time due to untimely (pre-mature) transfer from district Ramabai Nagar (Kanpur Dehat), wife's delivery, corona and due to some personal reasons. The applicant pleads apology and will ensure that future movable & immovable property statement will be submitted within time" mentioned in his attached letter dated 09.12.2021.

May, therefore, if approved, property statements of the financial years 2017-18 & 2018-19 of Sri Vivek Kumar Singh-I, Additional Chief Judicial Magistrate, Railway, Bareilly be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
