May kindly see the property statement submitted online received from Sri Rahul Singh-I, Additional District & Sessions Judge (POCSO), Lakhimpur Kheri regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2012-13 & 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2012-13 & 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2012-13 & 2013-14, total income is Rs.19,12,474/- (income from salary is Rs.16,78,228/- and income from surrender of Insurance policies are Rs.2,34,246/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, PPF, Insurance policies, NSC and the balance of his saving bank a/cs is enhanced for Rs.2,65,160/- in this financial year from previous year's balance, total of which is Rs.8,14,226/-. Thus, a sum of Rs.10,98,248/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice Ashok Pal Singh, the then Administrative Judge, Lalitpur in the misc. file of the officer. And of the financial years 2010-11 & 2011-12 are currently processed online on case-id no.P00010412021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2012-13 & 2013-14 in its next financial year i.e., 2014-15 upto March 2015. He has submitted movable and immovable property statements of the financial years 2012-13 & 2013-14 vide online dated 07.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has mentioned in remark column of movable property statement that "The applicant with folded hands begs to submit that his salary slip/register and bank passbooks were lost during annual transfer. It took time to recollect these papers from authorise sources. The applicant prays that Hon'ble Court may please to condone delay. For this act of utmost benevolence the applicant shall remain grateful and indebted to Hon'ble Court for the rest of his life".

May, therefore, if approved, property statements of the financial years 2012-13 & 2013-14 of Sri Rahul Singh-I, Additional District & Sessions Judge(POCSO), Lakhimpur Kheri be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and orders?
