May kindly see the property statement online received from Smt. Garima Singh, Additional Chief Judicial Magistrate, Banda regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2017-18 & 2018-19, Total Gross income from salary is Rs.15,84,277/- and total deductions/ repayment/ savings/ investment against Income Tax, NPS, GIS, Car loan and the balance of her savings bank account(s) is enhanced for Rs.4,56,890/- this financial year from previous year's balance, total of which is Rs.9,79,009/-. Thus, a sum of Rs.6,05,268/- was therefore available with her to meet out the household expenditure of her family consisting two members in both the financial years.

It is pertinent to mention here that her husband is Assistant Engineer at Uttar Pradesh Power Corporation Limited having income of Rs.7,50,000/- per annum.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining into Judicial Service, which has already been seen by Hon'ble Mr. Justice Karunesh Singh Pawar, the then Administrative Judge, Banda.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements for the financial years 2017-19 firstly vide online dated 18.11.2021. As such, there is delay in submitting the same from the part of the officer for which she has stated that "she could not submit the property statement within the time due to unprecedented COVID 19 situation and also she was on maternity leave from 26.11.2020 to 24.05.2021 and further on child care leave from 25.05.2021 to 23.08.2021 and due to personal reasons. Hence for the delay in submission of statement, she sincerely apologise" mentioned in remark column of movable property statement proforma.

May, therefore, if approved, property statements for the financial year 2017-18 & 2018-19 of Smt. Garima Singh, Additional Chief Judicial Magistrate, Banda be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Banda for His Lordship's kind perusal and further orders?
