May kindly see the property statement online received from Sri Ashok Kumar Yadawa-II, Additional District & Sessions Judge (POCSO), Sambhal regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2016-18 (2016-17 & 2017-18), Total income from salary is Rs.35,72,160/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, Insurances, Infrastructure bond and FD, total of which is Rs.18,79,499/-. Thus, a sum of Rs.16,92,661/- was available with his to meet out the household expenditure of his family consisting of three members in both of the financial years. And the balance of his savings bank account(s) is reduced by Rs.3,76,167/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statements of the financial years 2014-16 (2014-15 & 2015-16) which is already been seen offline by Hon'ble Mr. Justice Shahibul Hasnain, the then Administrative Judge, Kanpur Nagar for His Lordship's kind perusal and orders in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online dated 18.11.2021. As, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has not mention any reason for delay.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Ashok Kumar Yadawa-II, Additional District & Sessions Judge (POCSO), Sambhal be laid before Hon'ble Mr. Justice Chandra Kumar Rai, Administrative Judge, Sambhal for His Lordship's kind perusal and orders?
