May kindly see the property statement online received from Smt. Manisha, presently suspended since 25.05.2023 and attached to the Etah headquarter, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2018-20 (2018-19 and 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial years 2018-20 (2018-19 and 2019-20)**, her gross income from salary is Rs.37,80,811/- and total deductions/Savings/investments GPF, GIS, Income Tax, PPF, Mutual Funds, Repayment of loans and Insurances are Rs.22,71,279/-. The balance of Rs.1,43,752/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.15,09,532/- was therefore available with her to meet out the household expenditure of her family consisting four members in the financial years 2018-20 (2018-19 and 2019-20).

It is to pertinent mention here that officer's husband (Judicial Officer, Uttar Pradesh) having annual income was Rs.14,97,144/- for the financial year 2018-19 and Rs.18,71,484/- for the financial year 2019-20 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2010-11 to 2017-18 in offline mode. Which had already been seen by Hon'ble Mr. Justice Gajendra Kumar, the then Administrative Judge, Ballia Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 and 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She had submitted movable and immovable property statements for the financial years 2018-20 (2018-19 and 2019-20) vide online dated 16.11.2021 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer's verbatim (in attachment): "Suffered badly due to covid-19 so could not submit well in time. I was remained hospitalized. I seek my sincere apology for delay in submitting the statement."

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 and 2019-20) of Smt. Manisha, presently suspended since 25.05.2023, and attached to the Etah headquarter, be laid before Hon'ble Mr. Justice Manish Kumar, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders?
