May kindly see the online property statements received from Smt. Shikha Rani Jaiswal, Additional Principal Judge, Family Court, Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2017-19 (2017-18 & 2018-19), Total Gross income from salary is Rs.29,13,498/- and total deductions/ repayment/ savings/ investment against GIS, CPF, Income Tax, PPF, Insurance policies, Sukanya Samriddhi Yojna and the balance of her savings bank account(s) has been enhanced for Rs.1,99,078/- this financial year from previous year's balance, total of which is Rs.16,18,302/-. Thus, a sum of Rs.12,95,196/- was therefore available with her to meet out the household expenditure of her family consisting four members in both of the financial years.

It is pertinent to mention here that her husband is practicing Chartered Accountant having annual income of Rs.13,64,000/- and Rs.13,15,000/- in the financial years 2017-18 & 2018-19 respectively.

In this connection it is submitted that she has already submitted her property statements upto the financial year 2016-17, which has already been seen by Hon'ble Mr. Justice B.Amit Sthalekar, the then Administrative Judge, Varanasi with the warning to be careful in submitting the property statements in time, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements for the financial years 2017-18 firstly vide offline letter dated 26.11.2018 and 2018-19 vide online dated 19.11.2021. As such, there is delay in submitting the property statement of the financial year 2018-19 from the part of the officer, for which officer has requested to kindly forgive him for delay in submitting the property statements in time, mentioned in attachment.

May, therefore, if approved, property statements for the financial year 2017-19 (2017-18 & 2018-19) of Smt. Shikha Rani Jaiswal, Additional Principal Judge, Family Court, Kanpur Nagar be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
