

## **Registrar(J)(Budget)**

May kindly see the property statements online received from Sri Prakash Tiwari, Special Judge (SC/ST, Pev. Of Atroci Act), Saharanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.41,95,147/- (total Gross income from salary is Rs.41,81,051/- and from other sources are Rs.14,096/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against Insurance policies, PPF, GIS, PLI, Tuition Fees, NPS, Mutual Fund, Income Tax, SIP, Home loan and the balance of his savings bank account(s) has also been enhanced for Rs.7,60,182/- this financial year from previous year's balance, total of which is Rs.26,98,816/-. Thus, a sum of Rs.14,96,331/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already been submitted his property statement upto the financial year 2013-14 which had already been seen offline by Hon'ble Mr. Justice P.K.S.Baghel, the then Administrative Judge, Meerut in the misc. file of the officer. And of the financial years 2014-16 & 2016-18, detailed online notes have been laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders on e-service ID P00009542020 & P00009592020 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-19 & 2019-20 firstly vide online dated 26.11.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "*property statement for the aforementioned periods was submitted earlier on 07.12.2020. The statements submitted were not found upto the mark and objections were raised on the ground of non-observance of two years block policy, directing the applicant to re-submit the revised statements in schedule two year block for financial year 2014-16, 2016-18 and 2018-20 respectively. In compliance of Hon'ble Court's direction, the revised property statements for the financial year 2014-16, 2016-18 and 2018-20 as per two years block policy is hereby submitted for Hon'ble Courts kind consideration. He has humbly requested to condone the bonafide delay in submitting the statements and place the same before Hon'ble Court for necessary action*", mentioned in attachment dated 30.03.2022.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Prakash Tiwari, Special Judge (SC/ST, Pev. Of Atroci Act), Saharanpur be laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders?
